IDFTA Conference/South Tyrol Photo Album – J. Clements

The 2004 International Dwarf Fruit Tree Association Annual Conference was held March 1-4, 2004 in Bolzano, Italy. I first visited the South Tyrol in 2001 on an IDFTA Study Tour.
